### STAR WARSTM: UNLIMITED GALACTIC CHAMPIONSHIP

#### **OFFICIAL RULES**

Important: Please read these Official Rules ("Official Rules") before entering this Star Wars: Unlimited Galactic Championship tournament (the "Tournament"). By participating in this Tournament, you ("you" or "player") agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below. We reserve the right to change, revise and modify the Official Rules and Tournament. Your continued participation in the Tournament after such change, revision or modification constitutes your acceptance of the same. Please read the Official Rules carefully.

Tournament void where prohibited by law. Subject to applicable federal, state, and local laws. By participating in the Tournament, you agree to the (1) AsmoConnect Terms of Use; (2) Melee.gg Terms of Service; (3) Starwarsunlimited.com Terms of Use; (4) Star Wars: Unlimited Tournament Regulations; (5) Fantasy Flight Games Master Event Document; (6) as applicable, the Star Wars: Unlimited Comprehensive Rules; and (7) the Terms of Service for Participation in the Star Wars: Unlimited Galactic Championship. In the event of a conflict between the terms of these Official Rules and (1)-(7) of the preceding sentence, the terms of these Official Rules will control, followed by the AsmoConnect Terms of Use, followed by the Star Wars: Unlimited Tournament Regulations.

- 1. Eligibility: The Tournament consists of multiple events spread over 3 days. Some events require player to have an invitation from Sponsor to be eligible to play. The Tournament is open only to individuals who (1) are legal residents of their jurisdiction of residence; (2) are not suspended or otherwise banned from Fantasy Flight Games Organized Play events; and (3) where required, received an invitation from Sponsor. Directors, officers, members, managers, and employees of Asmodee North America, Inc ("Sponsor"), Disney Consumer Products, Inc., Lucasfilm Ltd., LLC, The Walt Disney Company, and any of their respective parent companies, affiliate companies (excluding affiliate marketers), subsidiaries, agents, professional advisors, advertising, promotional, public relations, and fulfillment agencies, consultants, legal counsel, website providers, and web masters, are not eligible to win any prize. Immediate family members (spouses, parent, child, sibling, grandparent, and "step" child, wherever they may live) of directors, officers, members, managers, and employees of Sponsor and its affiliates are not eligible to win any prize. If you do not meet any of these requirements, or any other eligibility requirements in these Official Rules, you are not eligible to win a prize. To be eligible to win a prize, entries must be completed and received by Sponsor in the manner and format designated below. If you are under the legal age of majority in your state of residence (a "Minor"), one of your parents or legal guardians agrees that they have read, understood, and agree to these Official Rules with your entry, and that such agreement constitutes acceptance of these Official Rules on behalf of you and themselves. A Minor must provide a Parental Consent Form signed by a parent or legal guardian prior to admission to the Tournament. For clarity, (a) any parent or legal guardian of a Minor agrees that all references to "you" throughout these Official Rules will include both the parent or legal guardian and the Minor; (b) you represent, agree, and warrant that you have read and understand the Official Rules, the AsmoConnect Terms of Use, the Melee.gg Terms of Service, and the Terms of Service for Participation in the Star Wars: Unlimited Galactic Championship, and are authorized to accept such terms and rules on behalf of both you and the Minor; and (c) in the event you (including the Minor) violate the Official Rules, the AsmoConnect Terms of Use, the Melee.gg Terms of Service, Star Wars: Unlimited Tournament Regulations, Fantasy Flight Games Master Event Document, or the Terms of Service for Participation in the Star Wars: Unlimited Galactic Championship, you agree to be responsible for any such violation. Sponsor reserves the right to confirm the credentials of any person participating in the Tournament. To be eligible to win a prize, entries must be completed and received by Sponsor in the manner and format designated below.
- **2. Tournament Period**: The Tournament occurs at The Venetian Resort Las Vegas. Start and end times for each portion of the Tournament (the "*Tournament Period*") are detailed in the table at <u>Exhibit A</u>. Times are subject to change. Sponsor's or its designee's computer is the official time-keeping device for the Tournament.
- 3. How to Register: To register, complete the following steps during the Tournament Period:

- c. Sign in or create a free melee.gg account by visiting <a href="https://melee.gg/">https://melee.gg/</a>. You must confirm your email address to complete your account creation.
- d. Register to attend the Tournament by visiting <a href="https://asmodee.swoogo.com/">https://asmodee.swoogo.com/</a>. Follow the instructions to select your registration type, provide the requested information, including the email associated with your melee.gg account, and registration fee payment, and agree to required terms for the event.
- e. Registration to play in some Tournament events will occur in melee.gg.
  - Registration for the Star Wars: Unlimited Galactic Championship Day 1 is open at <a href="https://asmodee.swoogo.com/">https://asmodee.swoogo.com/</a>. Melee.gg will contact players who have registered to attend the Star Wars: Unlimited Galactic Championship Day 1 via email with a link to enter this event. Follow the instructions, provide the requested information and agree to the Official Rules and all other required terms.
  - 2. Players who qualify for the *Star Wars*: Unlimited Galactic Championship Day 2 through a Season 0 Planetary, Sector or Regional Qualifier may confirm their participation while registering for the Tournament at <a href="https://asmodee.swoogo.com/">https://asmodee.swoogo.com/</a>. Players so qualified will receive an email from melee.gg with a link to register. Follow the instructions, provide the requested information and agree to the Official Rules and all other required terms.
  - 3. Players who qualify for the Star Wars: Unlimited Galactic Championship Day 2 by winning 6 or more matches or equivalent match points at the Day 1 tournament will be registered for the Day 2 tournament by Sponsor.
  - 4. Registration for the Galactic Open will open on July 25, 2025 at 9:00 PM Pacific Daylight Time. To register for the Galactic Open, melee.gg will contact players who have registered to attend the Galactic Open via email with a link to enter this event. Follow the instructions, provide the requested information and agree to the Official Rules and all other required terms.

For all other events, registration will occur in person beginning at 10:00 AM Pacific Daylight Time on the day of the event. Players will register and pay the required number of Side Event Tickets at the designated registration desk for each event. Players in the "Bulk for Beginners" event may redeem their Draft Voucher for entry into one "Legends of the Force Draft Pods" event in lieu of paying Side Event Tickets.

<u>Limit</u>: one entry per event per person during the tournament period, except that players may enter an unlimited number of League Play matches. League Play prizes are limited; see <u>Exhibit B</u> below.

- **4. Identity of Player:** All registrations must be submitted by the individual entrant. Multiple players are not permitted to share the same email account. Any attempt to obtain additional entries through fraud, bots, or other illegitimate means will result in disqualification, at Sponsor's sole discretion.
- 5. Tournament Structure and Gameplay: The Tournament will use formats as described in Exhibit A. Formats are defined in the Star Wars: Unlimited Tournament Regulations. Players in Constructed Format events are expected to assemble and bring a compliant deck and all other required game materials as specified in the Star Wars: Unlimited Tournament Regulations. Players in Limited Format events are expected to build decks at the event according to the rules specified in the Star Wars: Unlimited Tournament Regulations. Gameplay and rules are subject to the rules, requirements, and limitations set forth in the Star Wars: Unlimited Tournament Regulations, Fantasy Flight Games Master Event Document, and Star Wars: Unlimited Comprehensive Rules. By participating in the Tournament, you agree to comply with all applicable Sponsor rules, whether set forth in these Official Rules,

<u>Star Wars</u>: Unlimited Tournament Regulations, <u>Fantasy Flight Games Master Event Document</u>, and <u>Star Wars</u>: <u>Unlimited Comprehensive Rules</u>.

6. Selection and Notification of Winner: The placement of players and winner(s) of the Tournament will be decided as set forth in the <u>Star Wars</u>: <u>Unlimited Tournament Regulations</u>, <u>Fantasy Flight Games Master Event Document</u>, and <u>Star Wars</u>: <u>Unlimited Comprehensive Rules</u>. All decisions relating to the Tournament including, but not limited to, the resolution of rules, games, or disputes, the application of penalty guidelines, or the declaration or placement of winners are in the sole discretion of Sponsor. The Tournament is a game of skill, determined by the performance of the players under the applicable rules.

All players receiving 6 or greater match wins or match points equivalent to 6 or greater match wins at the conclusion of the *Star Wars*: Unlimited Galactic Championship – Day 1 will be notified by email of their admission to the *Star Wars*: Unlimited Galactic Championship – Day 2. Players so invited by email will automatically be registered for Day 2 in melee.gg.

Players participating in League Play must report the results of their match to be eligible for a prize.

To the fullest extent permitted by applicable law, Sponsor may require each potential winner (and if a Minor winner, his or her parent or legal guardian) to sign an Affidavit of Eligibility and Liability/Publicity Release in order to claim his/her prize. If any required documents are not signed or if potential winner is otherwise unable to accept the prize as stated, the prize will be forfeited and will be awarded to an alternate winner in accordance with the judging criteria and metrics set forth in the applicable rules. If, by reason of a print or other error, more prizes are claimed than the number set forth in these Official Rules, the prize(s) will be awarded to the next highest scoring player in accordance with the judging criteria and metrics set forth in the applicable rules.

<u>Verification of Potential Winner</u>: Each potential winner is subject to verification by Sponsor, whose decisions are final and binding in all matters related to the tournament. A player is not a prize winner unless and until player's eligibility has been verified and player has been notified that verification is complete and no further action is needed.

7. Prize: See attached Exhibit B for full prize details and approximate retail values.

<u>Prize Restrictions</u>: All federal, state and local taxes associated with the receipt or use of any prize are the sole responsibility of the winner. Prizes are not transferable. No substitutions or exchanges of any prize (including for cash) will be permitted, except that Sponsor reserves the right to substitute a prize of comparable or greater value for any prize. Sponsor will not replace any lost or stolen prizes or prize components. Only the number of prizes stated in these Official Rules are available to be won in the Tournament.

Except for applicable manufacturer's standard warranties, the prizes are awarded "as is" and without warranty of any kind, express or implied (including any implied warranty of merchantability or fitness for a particular purpose).

Disclaimer: Sponsor and its affiliates, Disney Consumer Products, Inc., Lucasfilm Ltd., LLC, The Walt Disney Company, and their respective agents, directors, employees, information providers, professional advisors, consultants, contractors, legal counsel, public relations firms, licensors, licensees, officers, and advertising, fulfillment and marketing agencies, (collectively, the "Released Parties") will not be responsible for: (a) any late, lost, misrouted, garbled or distorted or damaged transmissions, registrations, or entries; (b) phone, electronic, hardware, software, network, Internet, or other computer or communications-related malfunctions or failures beyond Sponsor or the Released Parties' reasonable control; (c) any Tournament disruptions, injuries, losses or damages caused by events beyond the reasonable control of Sponsor or the Released Parties by non-authorized human intervention; or (d) any printing or typographical errors in any materials associated with the Tournament.
- 9. Limitations of Liability; Releases: Player acknowledges that there are potential hazards and risks of physical injury or illness incidental to participating in the Tournament and that not all risks can be fully eliminated. By participating in the Tournament, player freely and voluntarily assumes any and all risks which are incidental to the

Tournament, regardless of severity, except to the extent caused by the gross negligence or willful misconduct of Releasees, as defined below.

By participating in the Tournament, player expressly waives and releases any and all claims, now known or hereafter known, against Sponsor, Disney Consumer Products, Inc., Lucasfilm Ltd., LLC, The Walt Disney Company, and their officers, directors, managers, employees, agents, representatives, successors, and assigns (collectively, "*Releasees*"), on account of injury, disability, death, or property damage arising out of or attributable to participation in the Tournament, whether arising out of the ordinary negligence of Sponsor, its agents or employees, or any Releasees or otherwise. Player agrees not to make or bring any such claim against Sponsor or any other Releasee and forever releases and discharges Sponsor and all other Releasees from liability under such claims. This waiver and release does not extend to claims for gross negligence, willful misconduct, or any other liabilities that applicable law does not permit to be released by agreement.

Player shall defend, indemnify, and hold harmless Sponsor and all other Releasees against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including attorney fees, fees, the costs of enforcing any right to indemnification under this release, and the cost of pursuing any insurance providers, arising out of or resulting from any claim of a third party related to Player's participation in the Tournament, including any claim related to player's own negligence or the ordinary negligence of the Releasees.

Player consents to receive medical treatment deemed necessary if player is injured or requires medical attention during player's participation in the Tournament. Player understands and agrees that player is solely responsible for all costs related to such medical treatment and any related medical transportation and/or evacuation. Player hereby releases, forever discharges, and holds harmless Releasees from any claim based on such treatment or other medical services.

- 10. Use of Name, Likeness, etc.; Intellectual Property: To the fullest extent permitted by applicable law, entry into the Tournament constitutes permission for Sponsor and its parent companies, subsidiaries, affiliates, agents, and designees to broadcast, stream, film, transmit, publicly display, record and/or take photos of gameplay during the Tournament, and Sponsor may use the resulting content, video, audio, footage, film, recordings or photos for a range of purposes, including, without limitation, for marketing, advertising, and promoting Sponsor and its respective products and services. By participating in the Tournament, player (and if such player is a Minor, his or her parent or legal guardian) hereby consents to having his or her gameplay broadcasted, streamed, filmed, transmitted, publicly displayed, recorded or photographed, and grants Sponsor and those acting under its authority (and agrees to confirm that grant in writing) the royalty-free, perpetual, irrevocable, sub-licensable, right and license to publish, reproduce, perform, distribute, publicly display, broadcast, stream, transmit, adapt, edit, modify, translate, create derivative works based upon, and otherwise use and display any or all of the content and details of such participation without additional compensation, including player's actual name, in-game name, team name, deck composition, photo, voice and/or likeness, and any of the content, video, audio, footage, film, photos or recordings taken pursuant to this section without further notice, review or approval, without territorial, time, media or medium or other limitations, for any and all purposes, including, but not limited to, marketing, advertising, and promotional purposes. By entering this Tournament, you consent to being contacted by Sponsor for any purpose in connection with this Tournament.
- 11. - **12. - 13. Disputes: To the fullest extent permitted by applicable law, each entrant agrees that any disputes, claims, and causes of action arising out of or connected with this tournament or any prize awarded will be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the District of

Minnesota or the appropriate state court located in Minneapolis, Minnesota. These official rules are governed by the laws of the State of Minnesota, without regard to choice of law or conflict of law rules. You waive any and all objections to jurisdiction and venue in these courts and hereby submit to the jurisdiction of those courts.

14. General Conditions: Players agree to be bound by these Official Rules and by the decisions of Sponsor, which are final and binding in all respects. Sponsor reserves the right to change these Official Rules at any time, in its discretion, and to suspend or cancel the Tournament or any player's participation in the Tournament should viruses, bugs, unauthorized human intervention or other causes beyond Sponsor's reasonable control affect the administration, security or proper play of the Tournament, or Sponsor otherwise becomes (in its discretion) incapable of running the Tournament as planned. Players who violate these Official Rules, violate any law, rule or regulation in connection with participation in the Tournament, tamper with the operation of the Tournament or engage in any conduct that is detrimental or unfair to Sponsor, the Tournament or any other player (as determined in Sponsor's discretion) are subject to disqualification from the Tournament. Sponsor reserves the right to lock out persons whose eligibility is in question or who have been disqualified or are otherwise ineligible to enter the Tournament. Sponsor reserves the right to disqualify any registrations received that contain inappropriate or offensive content. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. Any provision of these Official Rules deemed unenforceable will be enforced to the extent permissible, and the remainder of these Official Rules will remain in effect. Each player participating in the Tournament (and the parent and legal guardian of each, if a Minor) represents and warrants to Sponsor that the player's participation in the Tournament will not reflect negatively on Sponsor, its brands, products or services. All players agree to behave in an appropriate, sportsmanlike, and respectful manner towards other players and viewers. Unsportsmanlike conduct (e.g., excessive trash talking, inappropriate language, disruptive behavior) may result in an immediate disqualification from the Tournament, in the discretion of Sponsor, its designee, or judges. The use of the terms "include" or "including" in these Official Rules is illustrative and not limiting.
